## **CALL TO ORDER**

Superintendent Smith, Committee Vice Chair, called the meeting to order, welcomed attendees.

<u>Motion</u> by Mr. Carrera to approve minutes of the July 17, 2024, Committee meeting, second by Captain Carey. Unanimous approval.

## **Business**

- 1. <u>6VAC15-40</u>, <u>Minimum standards for jails and lockups</u>: Mr. Flaherty reviewed the process for Board staff to continue review of the regulations with a plan to present recommendations for BLRJ consideration. Mr. Flaherty reported that Board staff dedicated several dates to regulatory review: August 21, September 4 and 5, 2024.
- 2. <u>6VAC15-40-1045</u>, <u>Supervision of inmates</u>: Mr. Flaherty reported the proposed document is currently being reviewed by the Office of Regulatory Management (ORM). Following review, the process requires posting on the Commonwealth's Town Hall website. Mr. Flaherty shared the success of collaboration with stakeholders throughout the process will continue.
- 3. §9.1-192 Code of Virginia Report of Inmate Death: Mr. Flaherty reported BLRJ has incorporated the required demographic information into the BLRJ Report of Inmate Death effective October 1, 2024. BLRJ collaborated with the Department of Criminal Justice Services (DCJS) to provide the requested information quarterly.
- 4. <u>Annual Capacity Report</u>: Mr. Flaherty reviewed the annual capacity report, which is mandated by the General Assembly and is due October 1, 2024. He thanked facilities for collaborations to provide the required information.

# OFFENDER MANAGEMENT SERVICES UPDATE

Mr. Jim Parks reported out of compliance cases: Males-1,141; Females-94; total-1,235.

Superintendent Chris Smith shared information regarding the issue of attorney access to jails. He also addressed the subject of veterans in jails.
