CALL TO ORDER

Superintendent Smith, Committee Vice Chair, called the meeting to order, welcomed attendees.

<u>Motion</u> by Mr. Hackworth to approve minutes of the November 20, 2024, Committee meeting, second by Dr. Trent. Unanimous approval.

POLICY & REGULATIONS COMMITTEE (PRC) UPDATE

Dr. Booker reported the Continuous Quality Improvement (CQI) implementation is progressing and a template will be developed to detail standards and guidance for self-audit compliance. PRC meeting discussion included a suggestion for committee agenda to include Committee member names. She reported the 6VAC15-40-1045 Supervision of Inmates guidance was effective December 19, 2024.

OFFENDER MANAGEMENT SERVICES UPDATE

Mr. Jim Parks reported out of compliance cases: Males-963; Females-145; Total-1108 Superintendent Smith reported the DOC intake staff has been responsive and supportive.

BUSINESS

- 1. Mr. Flaherty welcomed DCJS representatives Sherry Johnson and Kevin Roach and reported the successful and continuing collaboration with DCJS is providing clarity for death reporting. DCJS plans to coordinate a work group to review death reports and translate data into recommendations to reduce deaths in custody, i.e. best practices, training.
- 2. Mr. Flaherty shared that BLRJ was contacted by a consulting group regarding Medicaid Section 5121 of the Consolidated Appropriations Act (2023). BRLJ facilitated discussion with stakeholders regarding the Department of Medical Assistance Services (DMAS) program of enrollment for juveniles. Superintendent Smith reported the Virginia Association of Regional Jails (VARJ) is working with DMAS and the consulting group regarding compliance.
- 3. Superintendent Smith reported there are several bills of interest in the General Assembly Session, scheduled to adjourn February 22, 2025. Superintendent Smith shared successful collaboration with BLRJ regarding pending legislation.
