CERTIFICATION, INSPECTIONS and AUDIT REPORTS

Tawana Ferguson, Regulatory Compliance Supervisor, presented the Certification, Inspections and Audit Report to the Committee.

- A. Virginia Beach Lock-Up, Third Precinct, requests de-commissioning as the facility is no longer in use. Staffing resources, technology deficiencies and budget restraints have added to the closure.

Motion offered by Mr. Hackworth to support de-commissioning the Virginia Beach Lock-up, Third Precinct, second by Mrs. Vermont.

- B. Essex County Lock-Up requests reclassification as a holding facility. The Committee requests additional information to address if the facility plans to hold inmates for any reason other than Court appearances.

6VAC15 Updates

6VAC15-40 Minimum Standards: BLRJ staff is reviewing the regulations and will continue to share drafts with the Committee.

6VAC15-20 Certification & Inspections: BLRJ staff is reviewing the regulations and will share drafts with the Committee.

6VAC15-45 Repeal of Regulations for Private Management and Operation of Prison Facilities is pending review by the Department of Planning and Budget (DPB).

Continuous Quality Improvements (CQI)

Ms. Lautz shared that the Committee input during the January 15, 2025, Committee meeting is reflected in the ongoing revision/consideration of the standards, as established for CQI in 2019. Implementation plans are in development.
