PURPOSE

The State Board of Local and Regional Jails (BLRJ) is statutorily obligated to annually report to the General Assembly and the Governor on the results of jail audits and inspections.

Code of Virginia (COV) §53.1-5. Powers and duties of the Board (8.)

To report annually on or before December 1 to the General Assembly and the Governor on the results of the inspections and audits of local, regional, or community correctional facilities conducted pursuant to § 53.1-68 COV. The report shall include (i) a summary of the results of such inspections and audits, including any trends identified by such inspections and audits and the frequency of violations of each standard established for local, regional, or community correctional facilities, and (ii) any recommendations for changes to the standards established for local, regional, or community correctional facilities to improve the operations, safety, and security of local, regional, or community correctional facilities.

DATA SOURCES

Sources for this report include jail records, annual inspections, and triennial audits conducted by BLRJ staff. The findings and data presented reflect inspections, audits, and compliance activities that occurred during January 1, 2025 – December 31, 2025. It should also be noted that ongoing corrective actions, follow-up reviews, and compliance verification activities taking place after December 31, 2025, are not reflected in this report.

JAIL AUDITS & INSPECTIONS

BLRJ compliance staff conduct annual inspections and audits of local and regional jails, lockups and federal detention centers to evaluate compliance with [Minimum Standards for Jails and Lockups](#) (6VAC15-40) of the Virginia Administrative Code (VAC). Each facility is subject to at least one compliance review annually via an annual inspection or triennial compliance audit.

The annual inspection is primarily focused on 43 life, health, and safety standards that are critical to the safe operation of the jail and assess compliance in areas such as fire safety, sanitation, security, medical services, and environmental conditions. Inspections take place annually unless there is a scheduled triennial audit taking place within that same year.

Compliance audits provide a more comprehensive review of facility operations and evaluate compliance with all 150 minimum standards. Audits are conducted on a rotating three-year cycle, ensuring that each facility's compliance with the full range of standards is assessed over time.

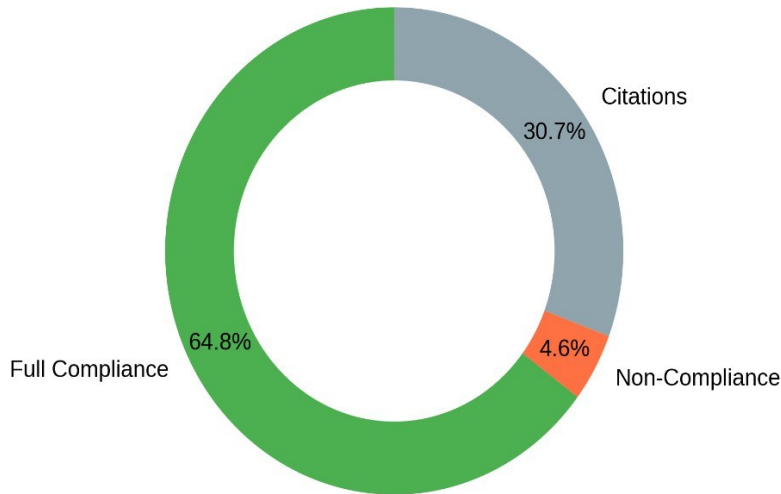
When a deficiency or citation is identified during an inspection or audit, the facility is required to develop and implement corrective action to address the issue. Compliance staff monitor corrective action efforts and may conduct follow-up inspections or site visits to verify implementation and sustained compliance. Additional inspections may also be conducted at the direction of the Board or in response to corrective action plan compliance.

In accordance with the definitions of [COV §53.1-1](#), Caroline Detention Facility and Farmville Detention Center are included in this report for reference. As a part of this process, these locations are reviewed for only the sanitation standards and not the full BLRJ standards outlined within 6VAC15-40.

CY25 Audit and Inspection Results

In CY25, BLRJ completed 29 audits and 59 inspections, at 82 local and regional jails, lockups and federal detention centers.

Figure 1: Percentage of jails that were in full compliance, non-compliance and cited.



- 57 audits/inspections resulted in full compliance.
- 27 audits/inspections resulted in citation of a minimum standard(s).
- 4 audits/inspections resulted in non-compliance.

ACTIONS AVAILABLE TO JAILS

When citations are documented during inspections and audits, jails are required to promptly implement corrective action. BLRJ compliance staff verifies corrective action implementation, effectiveness, and completion. Examples of corrective action available for jails to address documented citations include:

- Reviewing emergency medical policies for the jail and medical provider to enhance the continuity of care;
- Additional training for staff, e.g., formal re-training of staff regarding supervision of inmates;
- Accountability of staff and administration, e.g., deputies/officers/medical staff were terminated for violating policy and procedures;
- Featuring the importance of following jail policy and procedure during supervisory/officer meetings;
- Adding automated systems to track security rounds, sharps and narcotics;
- Enhancing medical care, e.g., additional medical staff;
- Changing health care contracted providers;
- Continuous Quality Improvement Program in health care services;
- Incorporating internal audits by supervisory and administrative staff to ensure compliance with regulations; and
- Ensuring Virginia Department of Health and Fire Marshal inspections are properly scheduled.

RECOMMENDATIONS & CONCLUSION

Context & Ongoing Work

BLRJ is responsible for establishing and maintaining operational and fiscal standards governing local and regional jails. Findings from audits and inspections continue to drive recommendations for updates to these standards.

The periodic review of 6VAC15-40 remains ongoing and BLRJ anticipates continuing this work through CY26, with a goal of publishing draft revisions in the Virginia Register of Regulations, followed by public comment and adherence to Administrative Process Act.

Staffing & System Needs to Support Effective Oversight

BLRJ has requested funding for two additional full-time employees, to strengthen its ability to carry out core oversight responsibilities. These positions were included in the House and Senate budget proposals, reflecting recognition of this shared need. These positions are critical to advancing BLRJ's ongoing review of standards and ensuring that regulatory updates are timely, relevant, and responsive to current operational realities within local and regional jails.

In addition to staffing, BLRJ requires a modern data management system to enhance its ability to track inspection and audit outcomes. Improved data capabilities will allow the agency to identify trends and patterns more effectively, supporting the development of targeted, evidence-based recommendations that drive meaningful and purposeful improvements to operational settings.

Conclusion

CY25 audit and inspection findings indicate a decline in the number of fully compliant jails. In response, BLRJ remains committed to working collaboratively with all stakeholders to promote safe, secure, and compliant environments for staff, inmates, and the public.

Jails across the Commonwealth continue to demonstrate resilience and commitment to public safety despite ongoing staffing and resource challenges. BLRJ recognizes these efforts and the progress being made to address identified deficiencies.
